JAMES SUNDQUIST RESPONSE TO CHARGES & ATTACKS **BY C&MA PASTORS RE CHINESE CHURCH SEIZURE**

Some of the retaliation by C&MA pastors was so swift, coming back only minutes after they received my email letter, that they couldn't even have had time to read the full 40 page report. Had they done so, they could have saved themselves much embarrassment and humiliation in their own false accusations against me. The letters of retaliation by C&MA pastors does not include all of those who asked to be removed from future mailings, exactly as I predicted, making a pretty convincing case that they too have no real interest in the plight of the Chinese Christians. The list is complete below, including my response to their letters. Therefore I have named names as the Apostle Paul commands and prepare a listed of C&MA pastors who have retaliated to the press release I sent out at the behest and SOS of the Chinese Christians whose church property and assets were wrongfully seized. Since many of them repeat the same mantras that come back, I am able to consolidate and condense a response and have posted it on our

website. I have also forwarded this to the Chinese Christians, so they will be warned about these C&MA pastors too. But these responses are really no big surprise, for they treat with contempt both the victims and the messengers. It is also not surprising because these abusive replies are exactly what is in store for members of Purpose Driven Churches who dare oppose or even question their leaders when something is not biblical. Bottom line, these Chinese Christians are disposable and expendable in the C&MA. I will be sure to tell them that sharing their plight with so-called C&MA brothers in Christ was compared to spam from Nigeria. Of course, I have now removed those people from the mailing database, for I will have given them a second warning that they have not heeded, so I would not write them again anyway. Though I do know that the Vietnamese victims will be writing you.

I must admitted I am surprised at the quantity of heartless and merciless attacks from C&MA pastors and the paucity of emails from C&MA pastors that really cared for the Chinese Christians. But I do thank those C&MA pastors who did show genuine concern and compassion for these Chinese Christians. And in the process I learned of many other pastors and congregations who are victims of the C&MA's church transition agenda. I also wish to thank all of those Christians around the country that sent the Chinese Christian's press release out to C&MA churches in the U.S. And Canada and for the many ministry websites and Christian radio stations that have already run the story as well as the newspapers and magazines that have committed to running this story in the near future, particularly when they learn that this despicable travesty has now happened to a Vietnamese C&MA church in Long Beach, California.

COMPLAINTS REGISTERED AGAINST JAMES SUNDQUIST IN RESPONSE TO RECEIPT OF PRESS RELEASE

1. Many claim I did not invoke Matthew 18. First of all they are wrong. Secondly, Matthew 18 is primarily about a private matter...not public sinning, public teaching, etc which must be rebuked and exposed publicly. Shocked that none of these people who call themselves pastors would not know this.
2. They keep clamoring for the other side of the story they say I am somehow withholding from them, even though I supplied them with a 40 page report that quotes both sides of the story. Their letters prove they did NOT read the report.
3. They talk about rush to judgment another falsehood. The Chinese church spent years trying to reconcile with the C&MA and were scorned. They carried out Matthew 18 too. Furthermore, I spent months pouring over the documentation from both sides before publishing a report. And I have studied and researched PDC and CGM for more than 10 years. So I know exactly what they are up to in the C&MA. They are so

adamant about invoking Matthew 18. Mr. Wetzel never once exercising Matthew 18 before he defamed me publicly.

4. I am accused of drumming up animosity and dividing the church, when it was Rick Warren and the other CGM leaders who brought this plague into the church in the first place that caused the division among the brethren. If you want to oppose dividing the church, then confront the C&MA, not me.

5. As usual no one could refute my arguments because almost all of them didn't even read the report.

6. I am accused of malevolent motives, doing it for the money (see commentary on Terry Truffin letter [#19 below], and retaliating, when they don't even see that it was Mr. Wetzel, Mr. Spriggs who did the retaliating. I am not making any money off of this and have waived my royalties on my books opposing it. I did not accuse this pastor of being a pastor for the money because he gets a salary. Yet he couldn't wait to take an unwarranted pot shot at me. And what a hypocrite to accuse or imply I am doing this for the money, while the C&MA has just cleaned out the Chinese church of all their money in their bank and will rake in \$650,000 when the property closes Feb 29, 2008.

7. I exposed them for throwing the unacceptable saints into the thicket...standard PDC doctrine...and what do they do? Defend these men.

8. I am accused of causing strife. When in fact it was the C&MA programs and abusive leaders that caused this strife in the first place. I am therefore, the enemy because I tell them the truth?

9. I am told this is "none of your business"...this person (James Grumblin) is apparently not familiar with the story of the Good Samaritan or Paul's words that when one hurts in the body of Christ all are affected. This is not the C&MA's own private plague. And if Mr Grumblin would bother to read the report, he would see that this is very much my business.

10. One pastor (David King) is "very saddened to read your accusations against C&MA leaders." What should sadden this pastor is that his own colleagues would rape and plunder one of its own churches. What should sadden Mr. King is that he would not even have the spiritual discernment to confront them vs. attacking me. What he should be saddened about to the point of repentance is the full knowledge that he as a pastor who should have known better to allow the false teachers and divisive programs into the church in the first place. Yes those members in the C&MA throughout the country who signed unbiblical covenants and went along with it are responsible too. But these false shepherds who stumbled these children in the first place...it will be better for them if a

millstone were attached around their neck and tossed into the deepest sea. Typically these C&MA pastors are saddened when anyone attacks a C&MA leader, but rarely saddened for the true victims and poor peasant Christian regular members. And contrary to Mr. David King's bashing me with statements like "fomenting of discontent among the brothers", Jude more accurately described these men as "wild waves of the sea, foaming up their shame."

11. Most of these C&MA pastors have not read the full report. But the church at large will. The media is reading it and publishing it. Mr. Wetzel has tried to ban its members from reading the full report, and in so doing, deprive them of even hearing the C&MA's side of the story. The public will be smart enough to not listen to Mr. Wetzel's advice and will actually read the entire report and the courthouse filing.

12. Mr. David King accuses me of being angry and vitriolic and another wonders what childhood trauma produced such an angry and bitter person (sounds like he has been well school in the psychology false religion forced upon C&MA members, workers and missionaries). Mr. King is so fond psychology and psychotherapy, why doesn't he direct this question to Mr. Burg or Mr. Trempert and ask them what could possibly have caused you to rape and plunder a church...was it some childhood trauma? So why isn't the Apostle Paul guilty of vitriol, angry, bitterness for simply obeying Scripture and commanding us to expose the deeds of darkness, expose false teachers publicly? Was John vitriolic against Diotrephes, who, like Rick Warren and the C&MA leadership are guilty of:

3Jo 1:9¶I wrote unto the church: but Diotrephes, who loveth to have the preeminence among them, receiveth us not.

3Jo 1:10Wherefore, if I come, I will remember his deeds which he doeth, prating against us with malicious words: and not content therewith, neither doth he himself receive the brethren, and forbiddeth them that would, and casteth [them] out of the church.

13. I am accused of having no grace and mercy in my exposition of the truth. This is a truly astonishing statement in light of the fact that none of the leaders in the C&MA showed the Chinese church any grace and mercy...the very ones the pastors who are retaliating against me these retaliators cheer on and defend the perpetrators. So these letters from C&MA pastors are chalked full of contradictions and more lies.

14. These letters are so replete with ignorance, they don't even get it. David King accuses me of using "legal means to 'get your way.'" So he doesn't even know that I am not the one using any legal means. It is the Chinese church that is using legal means. Once again, by not reading the full report, these men make more false accusations and therefore bring even more reproach upon themselves and the Name of Christ,

compounding their guilt, and destroying the C&MA's own name credibility time after time.

15. Mr. King is shocked to read my list of Christian leaders I believe to be apostate, yet supplies no example and no refutation. If he is referring to Rick Warren or Nicky Gumbel, I have plenty of proof posted on our website and many other Biblical discernment site.

16. Dr. Berman asks me if I am a pastor, ordained. No, I am not. As I maintain in my public speaking as well as my books, I am simply and hopefully just a good Berean, who studies the Scriptures to see if these things be true. Had these C&MA pastors done their job, they would have rejected Purpose Driven and Alpha Course plague and a host of other false teachers. Had they done their job, I would never have needed to write two books exposing them. Besides every Christian should be a good Berean. Does a person have to be an ordained pastor to expose fraud and corruption and false teaching? Is that what he is implying?

17. Mr. David King warns me of Titus 3:10...same threat that PDC leaders and C&MA use to destroy other churches who oppose this plague, including the C&MA church in Elmira, NY.

18. If calling these C&MA leaders on the carpet who were caught red-handed is so reprehensible to the C&MA pastors and workers who are retaliating against me, then why is it permissible for them to bash me with their emails.

19. RE Rev. Terry Truffin. Here is my response to his blasting away at me:

a. He accuses me of using "I" in my letter to him too many times. But the press release does not have "I" in it once. The paragraph that does employ it, what pronoun would Mr. Truffin suggest I use "he" ? "they", "you". I had to use "I" or "me" for I am the one that Mr. Wetzel bore false witness against. So of course I am going to use that pronoun. If Mr. Truffin is so concerned about talking about self, why does he boast about being a pastor for over 20 years.

b. He says my letter has caused him to pray for me. But God does not hear prayers when you regard iniquity in your hearts and defend those who defraud their brother, and promote and countenance false teachers.

c. Doing this for the money? (see Paragraph #6 above).

d. He accuses me of being in violation of I Cor 6:5-8 regarding suing a brother.

Well, just like the other C&MA pastors who retaliated against me, did not bother to notice that I am not the one suing. In fact I told him this twice yet he still accuses me. If he and his colleagues are so upset about a brother being sued, then they should compel the C&MA leaders to meet the Chinese Christians on the way to court and offer to repent and give them their church and bank account back. If the C&MA leaders are so opposed to being sued, they should have thought of this before they took action that precipitated a lawsuit. Clearly these pastors have also not read Matthew Henry's commentary on I Cor 6:5-8 or my own commentary which I wrote years before this tragedy done to the Chinese Christians in Colorado. I Cor 6:5-8 is also talking about a personal offense and trivial matters. He is not talking about property such as a bank or church which is held in public trust. Members of the Chinese church must be good stewards of this public trust...and fend off wolves who would steal and plunder it. The Parable of the Good Steward does not teach us to take the three talents God gave us then turn it into zero, simply because some corrupt Christian leader decides to take the talents. God will not say to the Chinese church :”Why not be cheated?” He would likely say to them “why didn't you stop them?” “I gave you this church (talents) as a sacred trust! “ If is obvious that both are of little interest to Mr. Truffin.

e. Mr. Truffin seems to know with certainty that it was my “pride retaliated to Mr. Wetzel”. But it was Mr. Wetzel who retaliated against me. Once again these pastors are so blinded by their leaders and the church transition philosophy, they don't even see their own contradictions. What Mr. Truffin calls “pride” I call obedience to Scripture to expose publicly those who bear false witness publicly, and promote false teachers publicly...rebuking them sharply. So why wasn't it pride that Mr. Truffin (and the other C&MA pastors) who retaliated against James Sundquist?

f. More on Matthew 18. The Chinese obeyed this for 18 months but were ignored by C&MA leaders.. If anything, people are asking why the Chinese waited so long to sue? If Matthew 18 is so important to C&MA leaders why did they go public? Matthew 18 does not apply to me because what the C&MA did was public so how could I go to them with a private matter they had already made public. No, what they have done publicly must be rebuked and exposed publicly, unless they wish to scorn the Apostle Paul's instructions too.

g. Mr. Truffin states: “Does the witness and reputation for the Body of Christ as a whole mean anything to you?” Response: The C&MA should have thought of this before they plundered the Chinese Church? The C&MA should have thought of this before they imported a host of false teachers. The witness of Christ is dependent on truth and righteousness! And yes this does mean everything to me.

Wickedness triumphs when good men remain silent.

h. Mr Truffin states that “tens of thousands of members know about the reversionary clause embrace its contents.” Response: Mr. Truffin is indicted by his own testimony. The majority of people follow the wide highway to Hell. Only a minority remnant will enter Heaven. Poor argument for validity. This is like the Pharisees bragging how many recruits they have and don't even know they have become twice the sons of Hell for putting burdens on God's people, that God did not intend. Jesus Christ warns about these people too, that just because you are able to deceive the little children to stumble (tens of thousands) does not make you less guilty but more guilty. And it is not true anyway that the majority know about the reversion clause...I can cite case after case in which the C&MA did not tell its members about it. I asked leaders of a C&MA church involved in a building campaign about family members there, if they told the congregation about the Reversion Clause before they embarked on a financial pledge campaign and received no answers even upon further request. Finally, as corrupt as the reversionary clause is, it does have some fail-safe provisions that could have been adhered to in order to prevent this crisis. But once again, the retaliators don't bother to read the commentary on the Reversion Clause to know this. The C&MA expects the local congregation to shoulder all of risk of paying off the mortgage, while the C&MA suffers no risk, because they always had the property as collateral in the event the Chinese church had defaulted on its loan.

i. Mr Truffin tells me to: “widen your vision”. Widen it to what? To include Rick Warren's another gospel promoted in the Ladies Home Journal and Alpha Course, Emerging Church, Mysticism, Psychology, forced covenants, force tithing that the C&MA has implemented?

j. Mr. Truffin closes with his most astonishing statement of all: “Christians should stand in the gap for the weak and downtrodden. This is not a case of that”. Tell that to the Chinese Christians that the C&MA plundered.

k. Mr. Truffin says that I am slandering a denomination. False for it to be slander, an abomination to the Lord, it would have to be false. No one has yet refuted the evidence.

l. Mr Truffin admits that C&MA pastors will not come along side what he calls my “misguided mission.” Well it is certainly correct that no C&MA pastors have come along side the evicted Chinese who were swindled out of their church property, bank accounts, and Bibles. But in truth it is the C&MA misguided mission that is going to fail and will be made known throughout the world. If a watchman on the wall is misguided because he obeys Scripture and warns the

people of an invading army and plague, exposes the wolves in sheep's clothing, and helps those left bludgeoned by C&MA's propeller, left dismembered and pieces strewn, then my mission is misguided.

20. If these C&MA retaliators are so interested in knowing the truth, why aren't they contacting Keith Wong. He informs me that hardly anyone contacted him. So much for any interest in the other side of the story! His email address is on the Press Release. I am just one of a host of many messengers. If Matthew 18 is so important to the C&MA pastors who responded directly to me, why aren't you first going to Keith Wong with your offense that he is suing the C&MA? Out of approximately 2500 emails which were sent out to the published email addresses of C&MA pastors, workers, and members, only a couple of you even emailed Keith Wong at all, let alone to confront him. You feel so strongly about Matthew 18 and yet don't even write him. This is the height of hypocrisy.

21. Contrary to their accusations, I have recordings of the meetings, videos, stacks of correspondence between the opposing parties, copies of title deeds, transfers, corporate records. But these C&MA retaliators would know this if they bothered to read the full report. So before you all make any more false accusations against me, you had better read the report and get apprised of the facts.

22. In a letter from Pastor Rubens Ruba and Pastor Steve Chapple, Lewisburg Alliance church, Lewisburg, PA, asking to be removed from mailings from me state: "no need to try to GET OTHERS ON YOUR SIDE " Yet in email after email C&MA pastors complain that Matthew 18 was not invoked in this case (which they state in ignorance of the facts). But Matthew 18 does tell us to recruit two or more if brothers don't repent. The C&MA has not repented! Finally, I am not trying to get others on my side as such, but on the side of righteousness and warn the church at large what can be in store for them. And once again, no evidence of coming to the side or aid of the Chinese Christians.

23. And from another heartless C&MA worker who states:

"Dear Sir:

Your unethical use of e-mail has caused me to treat your letter the same as a scam letter from Nigeria. I would put your use of e-mail in the same category. Your lack of love for Christ's Church and for the lost of the world is clearly evident.

Comment: If Mr. Grames is so so concerned about the lost, he would oppose the false teachings the C&MA are promulgating to the lost such as Rick Warren's PDC. The Chinese Christians in Colorado now report that the lost of the world there now clearly tell them they have no interest in becoming Christians because of how the C&MA leaders treated them. And once again, this worker shows no concern for the lack of love for Christ's church by not confronting the C&MA perpetrators. What is unethical here is the repeated blind eye towards the plight of the Chinese Christians. So what does Mr. Grames propose? That we bring the world's lost into the C&MA church, so they too can experience wonderful love of God extended to the Chinese Christians in Colorado Springs?

No institution on earth is perfect, just as all of us in these earthly frames are imperfect, but consider the will of the one who was and is perfect.

Dear Andy Winters, Pastor of Zanesville Ohio C&MA Church,

I am responding to your response to the two letters I sent you regarding the C&MA lawsuit and the teachings of Rick Warren.

I am staggered by the fact that you have a "heavy heart"...but it is heavy for the perpetrators not the victims. Your response was not really a heavy heart but a heartless response to the plight of these Chinese Christians. It is obvious that you hold my expose of Rick Warren in complete contempt, but have not provided a shred of proof that I have born false witness against him. And I am not the only one who has warned the church about him. There are a number of biblical scholars throughout the world who have written books and documentaries expose his plague, such as Warren Smith, Pastor Bob DeWaay, Roger Oakland, Lighthouse Trails Publishing, Jacob Prash, Philip Powell, Dave Hunt, Johan Malan, and a host of others.. waste of time” for these Chinese Christians since it wasn't your church home that was pillaged and plundered or raped. The C&MA sure didn't think it was a waste of their time to steal it from these Chinese Christians. I am sure glad Martin Luther did not use your reasoning “no institution is perfect”. If my confronting the C&MA is so unacceptable, why is it OK for you to attack me? Total Income \$101,649.41, Total Expenses \$145,406.55, Net Income \$-54,474.04"


Nyjaj Vaj Second Letter to James Sundquist:

Thank you for sending this to us. You are to be commended. The Christian & Missionary Alliance is quickly slipping from its foundation – that of God's Word and is going the way of most post modern denominations. Their 'church growth' manipulation has destroyed many smaller churches and encouraged a drift from God's Word. Many of these new church plants are preaching a modern message that comes from the liberal seminaries and Christian colleges. Their only goal seems to be BIG churches – not salvation and sanctification.

The Alliance desperately needs to set up a double reversionary clause that allows Alliance churches to leave the Alliance and keep their church properties if the Alliance changes the theological/Biblical position which was held when a given church entered the Alliance. Many denominations have this reversionary clause. When a denomination goes liberal, the local church (because of the reversionary clause) is dragged down with the denomination. If a church could leave its denomination and keep its property – because the denomination has left its theological foundations, such legislation would hold denominations accountable to their original Biblical standards. As it is, denominations can sell off such church properties and fund their liberal agendas.

Alliance churches that are just 'affiliate churches' can leave the Alliance and keep their properties. They don't have to sign the reversion clause. We were an Alliance church until February of 2007. Our church left the Alliance after we confronted the Board of Managers about the Alliance having women pastors. While the Alliance national policy forbids women to be ordained, many of its Districts now have women pastors!
